	Document Name: Memorandum and Order (3 pages) By Order dated January 14, 2020, the Court Comment: scheduled a hearing on Petitioners' Application for Special Relief in the Form of a Preliminary Injunction (Application) for January 28, 2020. In their Application, Petitioners seek mandatory injunctive relief against Respondent, Kathy Boockvar, Secretary of the Commonwealth (Secretary), with respect to her responsibilities under Section 1105-A of the Pennsylvania Election Code. ¹ Petitioners, however, also seek an order prohibiting the use of the Express Vote XL in any election. In paragraph 3 of their Petition for Review, Petitioners identify three counties—Northampton, Philadelphia, and Cumberland—who, relying on the Secretary's certification of the Express Vote XL system in November 2018, "spent millions of dollars buying these new machines." Under the Election Code, the county boards of election, not the Secretary, place electronic voting systems into use. Based on the allegations in the Petition for Review and the relief Petitioners seek in their Application, the Court is concerned about the absence of participation in the preliminary injunction proceeding by the counties who would be most affected immediately by the relief Petitioners seek in their Application. See <i>Polydyne, Inc. v. City of Phila.</i> , 795 A.2d 495 (Pa. Cmwlth. 2002) (noting failure to join indispensable party is jurisdictional and may be raised by court sua sponte). The Court is aware of its opinion in <i>Banfield v. Cortez</i> , 922 A.2d 36 (Pa. Cmwlth. 2007) (en banc), where a divided en banc panel of this Court overruled an indispensable party preliminary objection in an action challenging the certification of electronic voting systems by the Secretary of the Commonwealth. Nonetheless, <i>Banfield</i> does not address the indispensable party question in the context of a preliminary injunction, where the relief sought would immediately bar the use of electronic voting systems by the counties who purchased them pending a final determination on the merits. Accordingly, NOW, this 15th day of January, 2020, it is hereby ORDERED that the parties shall appear before the Court for ORAL ARGUMENT on the question of whether the county boards of election that have purchased and intend to use the Express Vote XL system in the upcoming primary election (April 28, 2020) are indispensable to Petitioners' Application and, thus, must be joined as parties. Oral argument will be held on January 23, 2020, at 9:30 a.m., in Courtroom 3001 of the Pennsylvania Judicial Center, Harrisburg, Pennsylvania. A status conference for the Court and attorneys of record will immediately follow. Comment: Pending Resolution of Preliminary Objections and Parallel Federal Court Motion (Application) and upon consideration of Respondent's Notice of Procedural Development Regarding Respondent's Application, it is hereby ORDERED that the Application is DENIED.

Many of Respondent's arguments in support of the Application go to the merits of whether this Court should issue the preliminary injunction that Petitioners seek in this matter. They do not justify a stay of the Court's consideration of Petitioners' request for preliminary injunctive relief. Moreover, as Respondent acknowledges, the Court raised sua sponte the jurisdictional issue of whether Petitioners have joined all indispensable parties and has scheduled oral argument on that question in advance of the scheduled proceedings on Petitioners' Application. The Court has no intention of granting relief to Petitioners before determining whether the Court has subject matter jurisdiction to do so. Finally, Respondent offers no legal support for her request that this Court stay this proceeding in deference to a separate motion filed in the United States District Court for the Eastern District of Pennsylvania, particularly where this action involves claims based on a Pennsylvania statute and the Pennsylvania Constitution.
