The Petition for Review was filed outside of the 180 day time period from the date of enactment of Act No. 2019-77 during which this Court had exclusive jurisdiction to decide specified constitutional challenges to Act No. 2019-77. See Section 13(1)-(3). 2. Petitioners' alternative request for King's Bench or extraordinary jurisdiction is denied. 3. The case is immediately transferred to the Commonwealth Court. Justice Wecht files a concurring statement.
