AFTER COMPLETION OF THE ALCOHOL HIWAY SAFE DRIVING SCHOOL & ALL OTHER CONDITIONS, THIS PERIOD MAY BE REDUCED TO NO LESS THAN 6 MOS. OPTION 2- DUI FAST TRACK PROGRAM (A) DEFT SHALL SURRENDER HER PA DRIVER'S LICENSE TO CLERK OF CRTS' OFFICE, CRIM DIV, FORTHWITH. DEFT'S OPERATING PRIVILEGES SHALL BE SUSPENDED FOR A PERIOD OF 120 DAYS. DEFT SHALL COMPLY WITH ALL RULES, REGULATIONS & CONDITIONS OF LEHI CTY PROB DEPT. DEFT SHALL SUCCESSFULLY COMPLETE THE FOLLOWING PROGRAMS: (A) ALCOHOL HIWAY SAFE DRIVING SCHOOL; (B) SUCH COUNSELING AND/OR TREATMENT AS RECOMMENDED BY PROB OFFICER. DEFT SHALL PAY COSTS OF THIS PROCEEDING & ALL PROGRAM COSTS APPROVED BY THE COURT FORTHWITH OR IN SUCH INSTALLMENTS AS APPROVED BY THE PROBATION OFFICER. THE PROMPT & FULL PAYMENT OF COSTS & COMPLETION OF TREATMENT ARE NECESSARY FOR RESTORATION OF OPERATING PRIVILEGE. DEFT SHALL MAKE RESTITUTION AS DET BY PROB DEPT, OR, IN EVENT OF DISAGREEMENT, AS DET BY THE COURT. THE COURT SHALL BE ADVISED PROMPTLY IF DEFT DOES NOT COMPLY WITH THE PROGRAM.
