Court Rejects Agreed Upon Statement Pursuant to Pa.R.App.P. 1924

AND NOW, this 30th day of November, 2016, by and through this ORDER, this Court REJECTS "Defendant's and Commonwealth's Agreed Upon Statement of Record Pursuant to Pa.R.App.P. 1924," and CLARIFIES its ruling from the bench at an April 7, 2016 oral argument. This Court specifically stated that the Court would grant the Defendant's "Motion for Access to Full Transcript of February 5, 2016 Sentencing Proceeding" and unseal the requested Notes of Testimony. Thereafter, said Notes would be transcribed and placed in the Court's normal recordkeeping system in the office of Judicial Records, allowing Defendant and all other persons to request those Notes in the normal course of business. Defendant explicitly withdrew his Motion twice on the record. (N.T. 4/7/16, p. 31 and 34). This Court accepted Defendant's withdrawal of said Motion and therefore no further ruling was entered on the docket. Accordingly, this Court does not approve "Defendant's and Commonwealth's Agreed Upon Statement of Record Pursuant to Pa.R.App.P. 1924,"(1) and it SHALL NOT be certified to the appellate court as the record on appeal. (1) Pa.R.A.P. Rule 1924 states, in pertinent part, that "[i]n lieu of the record on appeal as defined in Rule 1921 (composition of record on appeal), the parties may prepare and sign a statement of the case showing how the issues presented by the appeal arose and were decided in the lower court and setting forth only so many of the facts averred or proved or sought to be proved as are essential to a decision of the issues presented. If the statement conforms to the truth, it, together with such additions as the lower court may consider necessary fully to present the issues raised by the appeal, shall be approved by the lower court and shall then be certified to the appellate court as the record on appeal, and transmitted thereto by the clerk of the lower court within the time prescribed by Rule 1931 (transmission of the record)." The spirit and letter of this rule is to allow the parties and trial court to recreate a record of what transpired in court in the absence of the official record. This is not an issue in the case at bar as the entirety of the April 7, 2015 oral argument proceeding has been transcribed. A review of Pennsylvania law shows that there are 28 reported Superior Court, Supreme Court and Commonwealth Court decisions since 1978 with citation references to Rule 1924. Twenty-two of these cases involved matters where the transcript from the lower court proceeding was missing or otherwise unavailable and had to be recreated for the purposes of appellate review. In three cases, the appellate court reviewed issues using an agreed upon 1924 Statement; however, it is unclear from the opinions whether the trial court transcripts were available. (see Commonwealth v. Neiswonger, 488 A.2d 68 (Pa.Super.1985); Commonwealth v. Mason, 397 A.2d 408 (Pa. 979); Commonwealth v. Maldonado, 393 A.2d 962 (Pa.Super.1978)). One case involved the Superior court directing the parties and trial court to agree to a Statement pursuant to Rule 1924 in order to clarify the nature of a pro se filing, (see Commonwealth v. Wrecks, 934 A.2d 1287, 1288 (Pa.Super.2007); 931 A.2d 717,23 (Pa.Super.2007). In a case involving lack of notes of testimony from a voir dire proceeding, Defendant proposed an agreed upon Statement pursuant to Rule 1924. Both the opposing party and the trial court rejected the statement, and the Commonwealth Court declined to review the voir dire issue as a result since Rule 1924 is not mandatory. (see Allen v. Thomas, 976 A.2d 1279 (Pa.Cmwth.2009). Last, in Shughart v. Com. Dept. of Transp., Bureau of Traffic Safety, 442 A.2d 1206, fn 1. (Pa. Cmwth.1982), the parties, with trial court approval, submitted a Statement pursuant to Rule 1924 in addition to the certified record; however, the Commonwealth Court chose to ignore it and rely on the certified original record instead to..

In response to Petitioner's other various filings, this Court exercises its King's Bench jurisdiction. See 42 Pa.C.S. §502; see also Commonwealth v. Chimenti, 507 A.2d 79 (1986) (discussing King's Bench jurisdiction as an exercise of this Court's inherent supervisory powers).
