You must NOT possess firearms (including replica guns) or any other deadly weapons, possess, use, sell or distribute controlled substances of any kind.

You are not permitted to leave Philadelphia without approval of your Probation/Parole Officer (Additional travel requirements apply to Megan's Law)

You must report to your Probation/Parole Officer as directed and permit your Officer to visit you at your home of place of employment. Seek and maintain employment and obey all criminal laws and city ordinances.

Notify your Officer within 72 hours of any new arrest, change of address or change in employment.

You may be ordered to pay supervision fees, undergo a personal search and/or property search, attend a Life Skills Training Course and submit to a DNA sample if convicted of certain offenses.

You must NOT have contact with the victim, unless authorized by the Court.

You must complete Domestic Violence Therapy through a licensed therapist, psychiatrist or psychologist trained to give Domestic Violence specific counseling by a facility already approved by the department, pay for the costs of being evaluated and any future treatment deemed necessary by the evaluator and submit all requests for travel outside of Pennsylvania at least 30 days in advance and if approved by the Court, sign an extradition waiver.

Defendant paroled immediately to house arrest.

You must return the Electronic Monitoring Arrest (EM-HA) equipment provided by the FJD within (10) days of the termination of your electronic supervision. If you fail to do so, or if the electronic monitoring equipment s damaged when returned, you will be assessed the cost of repair or replacement. While the replacement cost may increase, the cost as of January 2021 is as follows: RF Patrol Transceiver (PTX): \$250; RF Patrol Home Monitoring Unit (HMU): \$600; and BA/RT Unit (Breathalyzer): \$500.

You are NOT permitted to leave your home without permission from your Probation/Parole Officer or touch, move or damager the electronic monitoring equipment.

You must maintain electrical services at all time in your home, submit all time-out requests through written verification at least 2 business days prior to intended travel and submit a request to move residence to your Probation/Parole Officer

If employed you must provide written verification of current legal employment and work schedule through your employer, provide paystub at every office visit and immediately notify your Probation/Parole Officer if you do not go to work or are no longer employed. Call the Emergency Line if you must go to the hospital for a medical emergency and submit discharge paperwork.
