1. Defendant shall comply with all of the conditions as specified in the Court Order(s).
2. Defendant is required to report to the Probation Department when notified and to attend all scheduled appointments with their Probation Officer. If required, Defendant shall report to Pro-Track/Pro-Mobile and will pay the required program fee as instructed by their Probation Officer.
3. Defendant shall comply with all Federal, State, and Municipal laws and especially keep the peace. Defendant will notify their Probation Officer within 24 hours of any new arrest.
4. Defendant shall complete any type of treatment and/or rehabilitation program as per the supervision plan developed between the Defendant and their Probation Officer.
5. Defendant is required to have permission from their Probation Officer before changing their residence. Any change in phone number and/or contact information shall be reported to their Probation Officer within 24 hours.
6. Any change in Defendant's employment status shall be reported to their Probation Officer within 48 hours. If Defendant is unemployed, they shall actively seek and maintain employment once employed.
7. Defendant shall pay all fees and costs of prosecution as determined by the Clerk of Court and the Huntingdon County Probation Department.
8. Defendant is ordered to pay a fine of \$150.00
9. Defendant shall not leave the Commonwealth of Pennsylvania without permission from their Probation Officer.
10. Defendant shall not use or possess any type of illegal drug or non-prescribed drugs; nor will they be in the presence of anyone using, possessing and/or selling illegal drugs or paraphernalia.
11. Defendant shall submit a sample of blood, breath and/or urine when requested to do so by any member of the Huntingdon County Probation Department to determine the use/abuse of controlled substances and alcohol. Defendant will be responsible for payments of any fees involved in said testing, laboratory confirmations and/or testimony.
