The following Judge Ordered Conditions are imposed:

Condition

Community Service: 200 hours at site to be determined within 6 years.

Defendant as a condition of sentence, shall comply with Montgomery County and/or PA Board of Probation and Parole rules, regulations and special conditions of supervision and electronic monitoring if applicable. Attached and imposed.

The Court performed an individualized assessment and determines that the conditions imposed herein are necessary and constitute the least restrictive means available to promote the Defendant's rehabilitation and the public's protection.

Defendant shall pay the monthly offender supervision fee.

No contact with victim(s).

The Commonwealth waives notification of Parole for any Negotiated or Time Served sentences.

Judge Rothstein retains Parole Authority. Upon parole, defendant shall receive treatment consistent with the recommendations of the PPI. When defendant has served her minimum sentence, Judge Rothstein will hold a Parole Hearing and determine if defendant will be paroled at her minimum, whether she will serve her full sentence of 23 months or somewhere in between.

Ineligible for Reentry Plan.

Defendant is not eligible for good-time credit.

Defendant shall be subject to Adult Probation Mental health Supervision during her Parole and Probation. Defendant shall be subject to random drug testing by Probation. Defendant is not entitled to the benefit of the revised Probation Laws and not entitled to a Probation Review Conference or a termination of her Probation prior to serving the entire term of Probation. 42 PA CSA 9714g
