Condition

The Defendant shall pay a fine in the amount of \$300 plus all other fees, fines and costs mandated by law, local rule of court, or administrative order of court.

All financial obligations imposed in this order shall be paid in equal monthly installments unless modified by subsequent Order of this Court or by a written agreement, filed of record, entered between the Defendant and the Clerk of Courts Office. In the event a modification agreement is entered, the Defendant is directed to make payment pursuant to that agreement.

Def is granted 180 days to pay all costs and fines.
