Defendant is sentenced to the DUI ALTERNATIVE TO JAIL program to commence within 90 days of this date. The defendant must pay the DUI Alternative program cost within 60 days of this sentencing date. During the DUI Alternative program the defendant is required to complete all DUI conditions as determined by the Court and participate in all other components of the program and follow all rules of the program and all directives of the program administrators. Defendant shall also pay a fine in the amount of \$1,000.00. Defendant shall serve a term of 6 months probation, concurrent to the DUI Alternative to Jail program.
