The following Judge Ordered Conditions are imposed:

Condition

The Defendant must participate in and successfully complete any program care, treatment, education, or rehabilitation as designated herein or deemed appropriate by the court or probation officials following complete evaluation and assessment.

As a special condition of Probation, Defendant may not own animals during supervision.

Defendant agrees to the forfeiture of all animals seized on June 7, 2024.

Defendant agrees to forfeiture and destruction of the firearm in question.

No fine is imposed on Count 1 or Count 10. Defendant shall pay all fees, fines, and costs mandated by law, Local Rule of Court, or Administrative Order of Court.

Defendant is directed to provide a DNA sample at the request of Probation. No DNA fee is imposed as it would constitute an undue financial hardship.

All financial obligations imposed in this order shall be paid in equal monthly installments unless modified by subsequent Order of this Court or by a written agreement, filed of record, entered between the Defendant and the Clerk of Courts Office. In the event a modification agreement is entered, the Defendant is directed to make payment pursuant to that agreement.

The Defendant shall be automatically paroled at the expiration of the minimum sentence upon approval of a home plan and transfer to the state of Alabama.

The Defendant will be evaluated by the Adams County Department of Probation Services for participation in the automated reporting system and, if deemed appropriate, shall participate in said program.

The sentence is subject to the following Conditions of Supervision for Probation, Probation with Restrictive Conditions, and Parole.

- 1. Defendant must not commit any violation of the law and must report any contact with law enforcement officials.
- 2. Defendant must refrain from any assaultive behavior or credible threat to cause bodily injury to another, including acts committed against a family or household member. Defendant will not annoy or harass any victim or witness of their crime.
- 3. Defendant must agree to permit any Probation/Parole Officer to search their person, enter into and search their residence, vehicle or any other property under their control without warrant at any time upon reasonable suspicion of violation and to ensure compliance with all conditions of their sentence.
- 4. Defendant may not possess or have control of a firearm or dangerous weapon on their person, in their residence, or in their vehicle, unless otherwise waived by the court.
- 5. Defendant may not abscond and must report as directed by the Department of Probation Services. Defendant must notify the Department of Probation Services of any change in address or employment within 15 days.
- 6. Defendant must not possess, manufacture, sell, deliver, or use any non-prescribed controlled substances, with the exception of possession and use of a non-prescribed controlled substance that is legally permitted to be possessed and used for medical or treatment purposes as certified by an approved physician.
- 7. Defendant must submit to urine testing or breathalyzer as required by the Department of Probation Services. Urine samples must be provided within two (2) hours of request and be of sufficient quality and quantity for chemical testing.
- 9. If defendant has been sentenced to Probation with Restrictive Conditions with the restrictive time being served on house arrest or in the Adams County Adult Correctional Complex (ACACC), defendant must comply with all rules and conditions of house arrest and the ACACC. Defendant must not receive any formal misconducts while serving the restrictive time at the ACACC.
- 10. Defendant must comply with all special conditions ordered by the Court within their most recent sentencing or supervised bail order on the case noted above.
