Shall be prohibited from consuming any alcoholic beverage(s) and/or non-prescribed drugs.

You shall refrain from the possession, use, or have under your control, or in your residence, any rifle, shotgun, handgun, other firearms or ammunition or other offensive weapons.

Defendant shall be considered for work release during any periods of incarceration.

Defendant shall have no contact, directly or indirectly, or attempt to have contact, directly or indirectly, with BG.
