It is Ordered that the Defendant be released on Immediate Parole subject to the signing of his Parole conditions with the Probation Department and the receipt of reporting instructions from the State of New York.

The Court advises the Defendant on the record of its incorporation of all General Rules governing Parole Supervision in Pike County, a copy of which is attached to the Order along with any special conditions as Ordered by the Court.

It is Ordered that the Defendant attend a Pike County Licensed Drug and Alcohol Facility or its equivalent in the County and State of his residence for a Full Drug and Alcohol Assessment, and that he comply with any additional recommended treatment at his own expense until successfully discharged.

It is further Ordered that the Defendant refrain from the possession and /or consumption of alcohol and that he refrain from entering any establishment where alcohol is served while under supervision.

It is ordered that the Defendant pay Restitution to the Victim, Sue Ann Stoveken in the amount of \$6750.00.

The Court notes that the above Restitution obligation shall be a condition of the Defendant's Parole.

The Court has taken into consideration when Ordering Restitution, the amount of loss suffered by the Victim.

It is Ordered that the Defendant's supervision in this matter be transferred to the appropriate authorities in the State of New York.

It is further Ordered that the Defendant's driver's license or operating privilege be suspended for a period of twelve (12) months which shall take effect within sixty (60) days and for any extended period of suspension if the Pennsylvania Department of Transportation determines the Defendant to be a habitual offender.

It is Ordered that the Defendant not operate a motor vehicle in this State or any other State while under driver's license suspension.

It is Ordered that the Defendant submit to a DNA Draw as required by Pennsylvania Law prior to release from Incarceration.

The Defendant has the right to assistance of counsel in the preparation of the Motion and Appeal. The Defendant is further advised that if they is indigent, they may proceed in forma pauperis and proceed with assigned counsel as provided for in Rule 122 of the Rules of Criminal Procedure.
