Shall be eligible to participate in the Centre County Re-entry Program immediately and participate in any subsequent re-entry plan(s)

That you shall submit to a drug and alcohol evaluation and comply with any treatment, if recommended.

That you undergo a mental health evaluation and complete treatment as recommended.

Defendant shall have no contact, directly or indirectly, or attempt to have contact, directly or indirectly, with LL and LD, no entry into LL or LD's place of employment.

That you shall be prohibited from entering any public or private place of business that deals in or sells alcoholic beverages, with the exception of grocery or convenience stores provided you do not enter any section of such store(s) where alcohol is stored or offered for sale.

Shall be prohibited from consuming any alcoholic beverage(s) and/or non-prescribed drugs.

You shall refrain from the possession, use, or have under your control, or in your residence, any rifle, shotgun, handgun, other firearms or ammunition or other offensive weapons.

Defendant shall be considered for work release during any periods of incarceration.
