The following Judge Ordered Conditions are imposed:

Condition

Defendant is subject to DUI conditions; that the Defendant undergo a drug and alcohol evaluation and comply with treatment recommendations; that they successfully complete alcohol safe driving school; and that they not possess or consume alcohol or non-prescribed controlled substances while on supervision. The Defendant must comply with and successfully complete Act 122 treatment.

Defendant shall pay the mandatory fine in the amount of \$1,000, \$100 Act 198 fee, and a surcharge. As a cost of prosecution, Defendant shall pay \$242 to the Adams County General Fund, care of the District Attorney's Office. Defendant shall pay all other fees, fines, and costs mandated by law, Local Rule of Court, or Administrative Order of Court.

All financial obligations imposed in this Order shall be paid in equal monthly installments unless modified by subsequent Order of this Court or by a written agreement, filed of record, entered between the Defendant and the Clerk of Courts Office. In the event a modification agreement is entered, the Defendant is directed to make payment pursuant to that agreement.

The Defendant will be evaluated by the Adams County Department of Probation Services for participation in the automated reporting system and, if deemed appropriate, shall participate in said program.

The Defendant is advised as a result of this conviction, their license may be suspended for a period of time with notice provided by the Department of Transportation.

Defendant is placed on probation today and shall be transferred to house arrest with electronic monitoring at the direction of the Department of Probation Services.

The sentence is subject to the following Standard Conditions of Probation/Parole:

1. Defendant must not commit any violation of the law.
2. Defendant must refrain from any assaultive behavior which threatens or presents a danger to Defendant or others. Defendant will not annoy or harass any victim or witness of Defendant's crime.
3. Defendant must report as directed, by any Probation Officer, and comply with the written or verbal instructions including all Community Re-entry Rules and Guidelines if a re-entry, work release, or house arrest participant.
4. Defendant must agree to permit any Probation/Parole Officer, to search Defendant's person, enter into and search Defendant's residence, vehicle, or any other property under Defendant's control without warrant at any time upon reasonable suspicion of violation and to ensure compliance with all conditions of Defendant's sentence.
5. Defendant may not have any prohibited offensive weapons or firearms on Defendant's person, in Defendant's residence or in Defendant's vehicle while on active Probation/Parole, unless otherwise waived by the Court.
6. Defendant must obtain permission to change Defendant's residence and shall notify Probation within 24 hours of that change. Defendant will not be permitted to reside with persons on active probation or parole supervision, unless approved by Defendant's Probation Officer.
7. Defendant must report all police or law enforcement contact to Defendant's Probation Officer within the next business day.
8. Unless classified as physically or mentally disabled, Defendant must find and maintain employment and report any changes to employment within 24 hours. If Defendant is a juvenile, Defendant must attend school every day that school is in session and obey all rules of the school authority.
9. The Defendant shall complete community service in accordance with Admin. Order 3 of 2018.
10. Defendant must not leave the Commonwealth of Pennsylvania for more than 24 hours or stay overnight at any place other than Defendant's approved residence without obtaining written or verbal permission.
11. Defendant must comply with all Court-ordered financial obligations including the payment of child support.
12. Defendant must abide by the following designated curfew until modified at the discretion of Defendant's Probation Officer: Adults: 10:00 p.m. Juveniles: 9:00 p.m.
13. Defendant must not possess or use any non-prescribed controlled substances and provide proof of any valid prescriptions as directed to do so.
14. Defendant must submit to blood/urine testing as required by the Department of Probation Services. Specimen must be provided within 2 hours of request and be of sufficient quality and quantity for chemical testing.
15. Defendant must comply with all specific conditions dictated by the Court within Defendant's most recent sentencing, juvenile dispositional or supervised bail order(s) on the Case(s) noted above.
16. Defendant must complete all Court-ordered evaluations or assessments. Defendant must participate in and successfully complete any programs of treatment or counseling recommended by and Drug and Alcohol or Mental Health evaluation or assessment.

The Defendant has acknowledged the violations set forth in the report. The Court therefore finds the program is no longer an effective rehabilitative tool and revokes the Defendant from participation in the program.

The Defendant's sentence is subject to all standard conditions as well as all special conditions set forth in previous Orders of Court, including financial conditions contained therein. To the extent Defendant has made payment pursuant to those orders, appropriate credit will be given.

The Defendant will be evaluated by the Adams County Department of Probation Services for participation in the automated reporting system and, if deemed appropriate, shall participate in said program.

All financial obligations imposed in this order shall be paid either in lump sum or in equal monthly installments unless modified by Order of Court or written agreement, filed of record, entered between the Defendant and the Clerk of Courts Office.
