Undergo incarceration in the Wayne County Correctional Facility for a period of not less than three (3) months nor more than twenty-three one half (23 1/2) months.

The following conditions apply to all counts:

No unsupervised contact with any child under the age of 18, unless approved by your parole officer.

Undergo a sex offender evaluation while incarcerated and comply with all treatment recommendations.

You shall advise your parole officer of having a computer or having any access to a computer and if it has internet service, and you shall notify your parole officer within seventy-two (72) hours of purchasing or acquiring any computer.

You will comply with any computer monitoring programs that are deemed necessary and at the discretion of your parole officer.

You are not allowed to access any pornographic sites or materials via a computer or the internet or utilize the internet to engage in relationships and/or conversations with minors, or have contact through any internet medium with the victim(s). You must provide your parole officer unlimited access to any computer or other wireless/electronic device in your possession, including but not limited to, cellular phones, smart phones, and like devices, and allow your parole officer to search all programs and records maintained on any computer or such other device in your possession.

No possession of pornographic materials.

You shall not enter adult bookstores, massage parlors, exotic dance establishments, or any establishment whose primary purpose is the sale, rental, or display of any sexually explicit materials. Refrain from the use of alcohol or illegal controlled substances, and the abuse of prescription drugs, over-the-counter drugs or any other substances, or frequenting places whose primary purpose is to dispense alcohol.

Submit to random drug and alcohol testing, which may include random drug testing through the SOS program as directed by the Wayne County Adult Probation Department.

Obtain a mental health evaluation and comply with all treatment recommendations.

Submit to personal and property searches pursuant to Title 42 Section 9912.

Obtain employment within sixty (60) days of parole or provide documentation from a physician precluding you from employment.

Pay \$50/month supervision fee to the Wayne County Adult Probation Department.

The Defendant is re-entry eligible.

The Defendant is not work release eligible.

Total sentence is three (3) months to twenty-three and one half (23 1/2) months WCCF.
