Defendant shall have no contact, directly or indirectly, or attempt to have contact, directly or indirectly, with K.C., FC., D.H., & N.B.. Shall be prohibited from consuming any alcoholic beverage(s) and/or non-prescribed drugs.

You shall refrain from the possession, use, or have under your control, or in your residence, any rifle, shotgun, handgun, other firearms or ammunition or other offensive weapons.
