### The following Judge Ordered Conditions are imposed:

#### Condition

Pay all costs and restitution in accordance with a contract in which a payment schedule will be established by the Centre County Probation and Parole Dept. This contract will be approved by the court.

Judgment shall be entered against you and in favor of the Centre County Probation and Parole Dept. for costs and restitution ordered to be paid by you.

That you undergo any evaluation deemed necessary and as arranged by the Centre County Probation and Parole Department and participate in any treatment programs as may be recommended as a result of any evaluation, and as approved by the Centre County Probation and Parole Department. This shall include complying with all mental health treatment recommendations, including a drug and alcohol evaluation.

That you undergo a mental health evaluation and complete treatment as recommended.

Defendant shall have no contact, directly or indirectly, or attempt to have contact, directly or indirectly, with K.C., F.C., D.H., & N.B..

Shall be prohibited from consuming any alcoholic beverage(s) and/or non-prescribed drugs.

You shall refrain from the possession, use, or have under your control, or in your residence, any rifle, shotgun, handgun, other firearms or ammunition or other offensive weapons.

Consecutive to any other sentence currently serving
