The defendant shall participate in and successfully complete the Court Reporting Network (CRN) Evaluation.

The defendant shall be eligible for the Weekender Program at the Franklin County Jail.

The defendant shall perform 25 hours in the Community Service Program.

The defendant shall pay court costs.

The defendant shall undergo MADD Victim Impact Panel.
