AND NOW, this 14th day of April, 2023, upon consideration of the Application for Disqualification and Leave to File Reply in Support of Application filed by Larry Krasner in his official capacity as the District Attorney of Philadelphia, and the Answers thereto filed by Senator Kim Ward in her official capacity as President Pro Tempore of the Senate, and Representatives Timothy R. Bonner and Craig Williams in their official capacity as impeachment managers, the application is denied as moot. Although there is no reasonable ground for my disqualification in this important matter, I have independently determined my recusal is nevertheless appropriate considering the unique facts and circumstances involved. 	For all of these reasons, we hold that the Articles of Impeachment passed by the House of Representatives of the 206th Session of the General Assembly, and transmitted to the Senate of the 206th Session of the General Assembly, became null and void upon the expiration of the 206th Session of the General Assembly on November 30, 2022. Accordingly, we must reverse that portion of the order of the Commonwealth Court which denied the DA summary judgment relief on this question. Order reversed in part. Jurisdiction relinquished.
