Comments:

Section 3755 is facially unconstitutional under the Fourth Amendment to the United States Constitution and Article I, Section 8 of the Pennsylvania Constitution.

The order of the Court of Common Pleas of Cumberland County is affirmed.

Chief Justice Todd and Justices Donohue, Dougherty and McCaffery join the opinion. Justice Mundy files a concurring and dissenting opinion. Justice Brobson files a concurring and dissenting opinion in which Justice Mundy joins.
