1 The Joint Motion was filed by Petitioners and Respondents the Department of Environmental Protection and the Environmental Quality Board. These parties report that "[c]ounsel for Petitioners contacted counsel for the [Independent Regulatory Review Commission (IRRC)] and [Legislative Reference Bureau (LRB)] seeking their concurrence with relief requested in this Joint Motion. In response, counsel for LRB indicated that the [LRB] does not concur with the relief sought in this Joint Motion. At the time of filing, IRRC had not responded to the request for concurrence." (Joint Motion, ¶ 8). Thereafter, IRRC filed an answer stating that it believes that the Petition and Application should either be withdrawn or dismissed but that "[n]onetheless, IRRC will neither challenge nor object to the request made in the Joint Motion."
