Colonel George Bivens, Acting Commissioner of the Pennsylvania State Police, has agreed to formally revoke the policy underlying the current litigation,¹ thereby rendering the matter moot, the Stipulation is APPROVED and the Court hereby directs as follows:

The preliminary injunction issued pursuant to this Court's January 31, 2020 Opinion and Order is hereby dissolved and the Prothonotary is ordered to return the cost bond, in the amount of \$100.00, to counsel for Petitioners Landmark Firearms LLC, US Rifle, LLC, Polymer80, Inc., and Firearms Policy Coalition, Inc.;
