Comment: NOW, January 2, 2025, upon consideration of the Emergency Application for Stay of Proceedings (Application) filed by Senate Majority Leader Joe Pittman, the Senate Republican Caucus, House Minority Leader Bryan Cutler, and the House Republican Caucus (Legislators), which seeks a stay of the proceedings in this Court pending a final order of the Pennsylvania Supreme Court in the matter docketed at 59 MAP 20241 regarding Legislators' appeal of the July 1, 2024 Order of this Court which denied Legislators' Application for Leave to Intervene, this Court issues the following Order:

Petitioners filed an answer in opposition to the Application on December 18, 2024. On December 26, 2024, Agency Respondents also filed an answer in opposition. On December 30, 2024, the Pennsylvania Independent Petroleum Producers Association, the Pennsylvania Independent Oil and Gas Association, and the Pennsylvania Grade Crude Oil Coalition (together, Association Intervenors) filed an answer stating that

although the Supreme Court denied proposed Legislator Intervenors' Application to Expedite Briefing and Argument, it nevertheless established a briefing schedule and expressly stated the denial was "without prejudice to seek a stay" of this action. Association Intervenors believe this reflects the Supreme Court's view that a stay of the instant proceedings is warranted and appropriate while it considers the merits of proposed Legislator Intervenors' appeal.

(Association Intervenors' answer, ¶ 48).

Upon review, this Court agrees with Association Intervenors that the Supreme Court's actions indicate that a stay of the proceedings in this Court is appropriate while it considers the merits of Legislators' appeal. Accordingly, Legislators' Application is GRANTED. Further proceedings in this Court are hereby STAYED pending resolution of Legislators' appeal before the Supreme Court.

1 The Supreme Court issued an Order on November 19, 2024 which denied Legislators' application for expedited briefing and argument without prejudice to seek a stay of the proceedings in this Court. We note that argument has not yet been scheduled in this Court on the pending preliminary objections.
