AND NOW, this 28th day of January, 2022, probable jurisdiction is NOTED. As Appellants waited ten days to file a notice of appeal from the Commonwealth Court's order denying intervention, and at least one of the case deadlines established by that order has already passed, the Order of the Commonwealth Court is AFFIRMED. Cf. Pa.R.Civ.P. 2329(3) (allowing for denial of intervention if "the petitioner has unduly delayed in making application for intervention or the intervention will unduly delay . . . the trial or the adjudication of the rights of the parties").
