However, nothing in this Order permanently enjoining strict enforcement of the dating provisions to disenfranchise voters shall preclude the enforcement of the remaining provisions contained within the dating provisions in Sections 1306 and 1306-D of the Election Code that are unrelated to the handwritten date requirement. 5. As prescribed by the Pennsylvania Supreme Court in Ball v. Chapman, 289 A.3d 1 (Pa. 2023), county boards of elections retain authority to evaluate absentee and mail-in ballots for compliance with the Election Code, including the dating provisions to ensure that the absentee and mail-in ballots are timely submitted by qualified electors, and thus prevent fraud.

	2) The other named respondents, the Philadelphia and Allegheny County Boards of Elections are not Commonwealth agents necessary to vest original jurisdiction in the Commonwealth Court. See 42 Pa.C.S. §§ 102 (providing "[t]he government of the Commonwealth ... does not include any political subdivision, municipal or other local authority, or any officer or agency of any such political subdivision or local authority."), 761(a); see also Blount v.
